## **Tega Cay Golf Club Tennis Membership Policies**

### **Instruction**

- Adult and junior clinic packages are available. Packages expire 90 days from date of purchase.
- Players must give a minimum of 24 hours notice if they are unable to attend a scheduled clinic to avoid being marked as a 'no show' for that date. No shows will count toward player's package as if player had attended.
- Clinics may be shortened, rescheduled or canceled due to low attendance, weather, or other unforeseen circumstances.

### **Benefits/Conditions**

- Members have the use of four courts adjacent to the water tower.
- Parking is available in the golf/tennis clubhouse parking lot.
- Food and beverages are available in the tennis clubhouse or the golf clubhouse or pavilion.
- Members must reserve courts using the online reservation system.
- Time limit of recreational play is one hour for singles and 1.5 hours for doubles if someone is waiting to use the court.
- There is a 15 minute wait for late arrivals before the court is considered open.
- Year-round key access to courts and rest rooms for members only.
- Proper attire is required and defined as follows: flat-soled non-marking shoes, shirts, shorts or pants. Swim wear, tank or tube tops, spiked shoes or dress shoes are not permitted.

### **Unattended Children**

- Please do not leave children unattended while using the tennis courts.

### **Guest Policies**

- Non-members may play an unlimited number of times for a court fee of \$5 per visit. If participating in a clinic, the court fee is waived and the non-member pays the non-member rate for the clinic.
- USTA teams may contain non-members. Each non-member on a Tega Cay team must pay a court fee of \$20 per season.
